Unless otherwise specified here as an overlay, all loans must adhere to all posted guidelines for FHA eligibility, as found in the [FHA Single Family Housing Handbook 4000.1](#). Down Payment Assistance is available to achieve 100% or 101.5% (DPA Deluxe only) CLTV with these three options: **1) DPA** (2nd lien is a zero percent (0.00%) Note rate, with a deferred, forgivable payment), **2) DPA Plus** (featuring a 2nd lien that has an interest rate equal to the first lien rate plus 2% with a 10-year amortization and monthly payments required), and **3) DPA Deluxe** (featuring a 2nd lien that has an interest rate equal to the first lien rate plus 2% with a 10-year amortization and monthly payments required).

<b>Product Eligibility</b>	<ul style="list-style-type: none"> <li>Temporary buydown only applies to first lien and is not applicable to the DPA product</li> <li>Must meet all terms of DPA program (DU® approve, etc.)</li> <li>Seller / Builder funded only</li> </ul>
<b>Term of Buydown</b>	<ul style="list-style-type: none"> <li>2/1 Buydown: <ul style="list-style-type: none"> <li>24-month term</li> <li>Initial interest rate temporarily reduced by no more than two percent below the note rate and increased by no more than one percent annually for no more than two years, with the non-reduced note rate applying for remaining term of loan</li> </ul> </li> </ul>
<b>Underwriting Criteria</b>	<ul style="list-style-type: none"> <li>Borrowers qualified using note rate, not buydown rate</li> <li>Standard Interested Party Contribution guidelines apply</li> <li>Temporary Buydowns do not apply to the DPA transaction – only to the first lien</li> <li>Seller / Builder funded only</li> </ul>
